The following information has been extracted from the audited financial statements which can be made available upon request.

The financial statements for the year ending 30 June 2020 show an operating deficit of \$1.38 million compared to a deficit of \$1.59 million last year.

This deficit has been supported by non operating income totalling \$3.24 million. This is made up of investment income, capital grants, donations and legacies leading to an overall surplus of \$1,863,642 compared to a surplus of \$1,198,250 last year.

The first chart below shows total operating income and the level of deficit funding provided by the organisation. The second chart shows the breakdown of the statement of financial position as at year end.

Robert's story

Many years ago Robert Hall promised himself that one day he would give back and now he is.

Robert volunteers as a mentor for 13-year-old James*. James lives with his mother and experiences ADHD so has energy to burn.

When Sarah Taylor, Family Works volunteer coordinator, compared the profiles of Robert and James, she quickly saw an ideal match. Now the pair regularly go tramping, camping, and kayaking and James spends time with an awesome male role

Robert hopes the experiences he shares with James will be "imprinted on his brain" and that he'll become "a useful member of society, not a drain"—perhaps like Robert's first mentee, who recently finished five years of high school and plans to become a chef. "That feels really good," said Robert.


Ted's story

Ted* was in his 70s when he decided he would like to live closer to his daughter. At the same time he also wanted to support her and her husband by loaning them money they had asked for. So Ted sold his home and loaned the money but that's when everything

While Ted did move in with his daughter and son-inlaw, he was forced to live in a sleep-out and was not allowed into their home. His car keys were taken off him and the promised loan repayments were never

By chance Ted had a conversation with a person who knew someone at Age Concern. They, along with the Police, intervened, having found Ted unwashed, unkempt and distressed. They put Ted in touch with Enliven. Multiples agencies helped Ted to get back on his feet. He is much happier these days. Counselling has helped and he has been able to connect with his local community through his love of gardening. Ted still has a long way to go, but his future is looking much brighter.






